## **Guest Speakers**

Mr. Edward K. F. Chow, JP is the founder of China Infrastructure Group, the chairman of the company and a chartered accountant. He is a past president of the Hong Kong Institute of Certified Public Accountants, a past chairman of the Professional Accountants in Business Committee of the International Federation of Accountants and a past deputy chairman of the Hong Kong Institute of Directors. Currently, he serves as an expert advisor of the Accounting Standards Committee of the Ministry of Finance, the PRC, a core member of the OECD/World Bank Asian Corporate Governance Roundtable, a council member of the Institute of Chartered Accountants in England and Wales and a vice chairman of the Business and Professionals Federation of Hong Kong. He is also an independent director of COSCO Pacific Limited and China Merchants Bank.

Mr. Vernon F. Moore joined the CITIC Pacific Group in 1987 and served as CFO and deputy managing director until 2005. Since October 2008 he has been the company's group finance director. He is chairman of the New Hong Kong Tunnel Company and the Western Harbour Tunnel Company, and an independent non-executive director of CLP Holdings. For 17 years he was a non-executive director of Cathay Pacific Airways, and has served on a number of other boards in the telecom, mining and financial industries. Prior to joining the CITIC Group in Hong Kong Mr. Moore spent 18 years in the banking and financial services industries. He is a fellow of the Institute of Chartered Accountants in England and Wales, and of the Hong Kong Institute of CPAs on whose Council he once served. Mr. Moore was a member of the Hong Kong Financial Reporting Council when it was first established. In earlier years he was a member of the Listing Committee of the Hong Kong Stock Exchange and the Securities and Futures Appeals Tribunal. He is deputy chairman of the Community Chest.
