

PAIB forum: Competition Ordinance – Getting Prepared for Full Implementation

About the topic

The development of competition law in Hong Kong has, at times, been controversial. However, after a long development phase the new Competition Ordinance will come into effect next year and arrangements for its full implementation are now being worked out. The Competition Commission is currently consulting business and other stakeholders on the drafting of guidelines on the application of the key competition rules under the ordinance. This event will enable members to hear from the Commission about its plans and to find out more about the new law and how it will operate. Given the consultation currently being conducted, this forum will also provide an opportunity for members to give feedback that could help to smooth the introduction of the new law, inform the Commission's guidelines and strengthen Hong Kong's competitive environment.
