#### **ABOUT THE SEMINAR**

Last February, the U.S. FASB decided to abandon its joint work with IASB on the <a href="Insurance Contracts project">Insurance Contracts project</a> and to continue with a smaller scope project which will only deliver targeted improvements to existing U.S. GAAP. The IASB has now completed most of its deliberations and is concentrating on the remaining thorny issue of the accounting for participating contracts before entering the balloting phase and publish the new IFRS in 2015. The Insurance Contracts project of the IASB has been in progress for many years. After one interim IFRS, a discussion paper and two exposure drafts, it now seems to be reaching its finish line with the IASB running the last mile of this marathon alone.

At the FSIG Seminar, Francesco Nagari, Deloitte global IFRS insurance lead partner, will give his perspective on the key characteristics of the new requirements and their impact on insurance companies reported profits. These requirements are complete from a general insurance point of view and subject only to the finalisation of the participating contracts accounting decision for life insurance companies. He will also briefly cover the FASB new plans.

### ABOUT THE SPEAKER

Mr. Francesco Nagari is the Deloitte Global IFRS Insurance Lead Partner.

Mr. Nagari has over 22 years of insurance accounting and business experience with a deep knowledge of some of the key European insurance markets and products. He leads several audit and advisory projects with multinational insurance companies in Hong Kong, London and Milan.

He is an expert on insurance reporting issues across IFRS, US, UK, French and Italian GAAP and on insurance IFRS transition from other GAAPs gained from his work as auditor, interim director of finance and business advisor to several insurance organizations.

As Deloitte leading insurance accounting expert, he has written several publications and regularly speaks at conferences on insurance IFRS reporting as well its interaction with solvency regulations.

He was a member of the Insurance Accounting Working Group of the European Financial Reporting Advisory Group ("EFRAG") which supports EFRAG and the European Commission influencing the development of IFRSs and their interpretation on insurance specific matters, their application within Europe with a particular focus on the endorsement decision of IFRSs that affect the insurance industry. He is one of the founding members of the Financial Reporting Group of the UK Actuarial Profession and was a member of the Financial Reporting Council Steering Group on the new UK standard on insurance contracts accounting.
