## DEPUTY DIRECTOR, ADVOCACY AND PRACTICE DEVELOPMENT (Ref. DD-A&PD)

The Advocacy and Practice Development Department is responsible for the development and promotion of the work of the profession in taxation. insolvency and restructuring, corporate governance, forensic accounting, anti-money laundering, professional liability reform, and in relation to relevant legislative/ regulatory matters. One of the significant regular projects of the department is the Best Corporate Governance Disclosure Awards.

## Role and Responsibilities

The successful candidate for the post of deputy director will be expected to be able to:

- Assist in developing, and manage, ad hoc technical and thought leadership projects relating to some of the above specialist areas, including corporate governance projects
- Provide technical and administrative support to committees, working groups and other technical/ specialist groups
- Co-ordinate and draft responses to legislative and policy proposals, consultation papers, etc., relating to relevant technical areas
- Draft technical information and papers, including newsletters, for dissemination to members, and assist in drafting good practice guidance. One current area of work of the department is to develop anti-money laundering guidelines
- Conduct/ coordinate research in relation to the department's projects
- Liaise with members and other internal and external stakeholders, including relevant government agencies, regulators and overseas bodies, as well as other departments within the institute

- Oversee/ coordinate the organization of activities and events (e.g., seminars, conferences and networking events)
- Respond to technical enquiries on relevant subjects handled by the department
- Coordinate departmental returns including budget preparation and monitor budget variances arising during the year
- Deputize for the department head, as and when required
- Some travelling is required but frequent travelling is not expected

## Qualifications and Required Attributes

The successful candidate will possess the following qualifications and attributes:

- A recognized university degree in accounting/finance/business
- CPA with a minimum of 10 years' post qualification experience gained in practising firms of CPAs or other organizations
- A strong technical background, preferably including knowledge of one or more of the specialist areas handled by the department
- High professional and ethical standards with a strong sense of commitment
- Ability to deal with different stakeholders and partner organizations in Hong Kong and internationally
- Well-organized, able to work on own initiative and to supervise some professional and administrative staff
- Excellent written and oral communication skills in English and Chinese. Good command of Putonghua would be an advantage
