**A Guide through IFRS 2013** includes the official announcements issued by the IASB as at 1 July 2013. It includes IFRSs with an effective date after 1 July 2013 but not the IFRSs they will replace. This edition is presented in two volume parts, sold together as a set:

Part A (the Conceptual Framework and requirements) contains complete and up-to-date consolidated text, with extensive cross-references and other annotations, of International Financial Reporting Standards (IFRSs), International Accounting Standards (IASs), and International Financial Reporting Interpretations Committee and Standing Interpretations Committee interpretations.

Part B contains the accompanying documents, such as illustrative examples, implementation guidance, bases for conclusions and dissenting opinions.

In addition, footnotes summarize technical issues considered but rejected by the IFRS Interpretations Committee.
