Mr. Christopher Justice was appointed as managing director of Quam (H.K.) Limited, a subsidiary of HK-based financial services group, Quam Limited, and owner of the website www.quamnet.com, on 10 April 2007. He took over responsibilities for Quamnet, a HK financial portal, and Quam IR, which provides traditional and online IR services to listed companies in HK and China. Christopher graduated from the University of North Carolina with a BA in Public Policy Analysis. He has a wealth of experience in finance, venture capital, strategy and business development. He is also experienced in Internet media in Asia. In 1996, he started scmp.com, an award-winning Internet site of the SCMP Publishers Group, and subsequently co-founded Asiacontent.com, an Internet media and advertising company listed on NASDAQ in early 2000.

Ms. Estella Ng Yi Kum is the chief financial officer of Country Garden Holdings Company Limited, a company listed in HK. She is also an independent non-executive director of Hong Kong Resources Holdings Company Limited, and holds various public service appointments, including co-opted member of the audit committee of the Hospital Authority and corporate advisor to the Business School of the HK University of Science and Technology ("HKUST"). From September 2005 to November 2007, Estella was an executive director of Hang Lung Properties and, prior to joining Hang Lung Properties in 2003, she was employed by the Stock Exchange in a number of senior positions, most recently as senior vice president of the Listing Division. Prior to that she gained valuable auditing experience with Deloitte. Estella holds an MBA degree from the HKUST. She is an associate of ICAEW and ICSA, a fellow of ACCA and HKICPA and a member of AICPA.

Ms. Wendy Yung is the executive director and company secretary of Hysan Development Company Limited, a property investment, management and development company listed in HK. As a member of the group's senior management team, Wendy oversees all the group's non-finance corporate services including legal, company secretarial, human resources/administration and corporate communications. A solicitor by training, Wendy practised with major law firms in Hong Kong, City of London and Canada. She holds a Master of Arts Degree from Oxford University. Wendy is also a member of the HKICPA. She sits on the Hong Kong Selection Committee of the Rhodes Scholarships and a number of committees of the HKICPA and HKICS.
