About the presentation

The "Greater Pearl River Delta region" - Hong Kong, Macau and the Pearl River Delta combined - is arguably the most dynamic economic region of the world. To sustain the growth potential, there is immense demand for infrastructure development within the Greater Pearl River Delta region. In this presentation, Dr W. K. Chan will discuss a few pertinent issues in infrastructure development in relation to the integration between Hong Kong and the Pearl River Delta, such as

- infrastructure needs and strategic options for the Pearl River Delta
- infrastructure linkage between Hong Kong and the Pearl River Delta
- impact of Pearl River Delta's infrastructure development
- strategic implications for Hong Kong, particularly on the role and future development of the Hong Kong port

About the Speaker

A Senior Director of the Hong Kong General Chamber of Commerce and a Director of the Geneva-based Service World Forum, Dr W. K. Chan is also the Secretary-General of the Hong Kong Coalition of Service Industries. He is the Hong Kong private sector's principle spokesman on the General Agreement on Trade and Services in international and multilateral forums such as the WTO (World Trade Organisation), APEC (Asia Pacific Economic Cooperation Council), and the International CSI Conference. Dr Chan is a member of the Town Planning Board, the Antiquity Advisory Board and an unofficial Justice of the Peace.
