In February 2014, the International Auditing and Assurance Standards Board (IAASB) released its publication, <u>A Framework for Audit Quality: Key Elements that Create an Environment for Audit Quality</u>. Through this Framework, the IAASB aims to raise awareness of the key elements of audit quality, encourage key stakeholders to challenge themselves to do more to increase audit quality in their particular environments, and facilitate greater dialogue between key stakeholders on the topic.

Given the importance of audit quality and to raise the awareness of stakeholders in Hong Kong who have an interest in continually enhancing audit quality (including regulators, audit committees, investors, and audit firms), this forum provides an opportunity for key stakeholders to explore ways to improve audit quality.
