### About the seminar

As a major international financial centre, Hong Kong cannot afford to allow its financial system to be used for the purposes of money laundering and terrorist financing. In this seminar, the Narcotics Division of the Hong Kong SAR Government, with the support of the Institute, will explain what accountants should do to prevent money laundering and terrorist financing.

This is part of a series of anti-money laundering ("AML") seminars organized by the Narcotics Division for "Designated Non-Financial Businesses and Professions ('DNFBPs')", which are now included under the international AML regime established by the Financial Action Task Force on Money Laundering. The objectives of the seminars are:

- ✓ To provide DNFBPs with an overview of the latest international and domestic AML developments.
- ✓ To enhance understanding of the statutory obligations and practices of suspicious transaction reporting.
- ✓ To provide a forum for discussion of matters of common concern on AML compliance and reporting.
