





The Institute is organising another go-karting weekend at *Xtreme Speedway* in Shenzhen. This will be a great experience for motorsports enthusiasts. Whether you are a first-timer or an experienced go-kart racer, you are welcome to join this exciting sport event.

*Xtreme Speedway* is the only A-grade national race course in the Shenzhen area which is qualified for national racing events. Fully equipped with safety gear, electronic scoreboard, and spectator viewing area, it is one of the closest and best go-karting venues in the Hong Kong – Shenzhen area.

Participants' safety is of paramount importance and all participants are required to strictly observe the rules and regulations and instructions from the event's leader, Michael Wong. The Paramedic Extrication Support Rescue Team will be there to offer on-site paramedic support.
