The Head of Corporate Communications and Member Services supports the Director, Marketing and Communications in the development and implementation of the Institute's communication strategies to promote the Institute's branding; and the oversight of the planning and organization of major corporate events, and sports and recreational activities.

Role and Responsibilities

- Develop and implement the Institute's integrated strategies on corporate communications media relations, social media, thought leadership, publications, corporate social responsibility and charity.
- Respond to media queries, identify opportunities for media interest and keep the management informed of opportunities to advance the reputation and standing of the Institute, as well as emerging issues that could be a threat and formulate the corresponding communication strategy.
- Develop core messages and content to create engagement through online channels and social media, including website, Facebook, Linkedin and WeChat.
- Promote the Institute as a globally recognized top-tier accounting body by actively participating production of white papers and comment letters.
- Oversee the quality and production of the Institute's publications including the monthly magazine, annual report, brochures, publicity materials and promotional publications.
- Develop CSR and charity strategies, oversee the initiatives such as "Rich Kid, Poor Kid" and "CPA for NGO", build relationships with NGOs, and manage the administration of the Institute's Trust Fund and Charitable Fund.
- Take ownership of all corporate events and liaise with external vendors, service providers, stakeholders and professional organizations on collaborative projects. Review budgets and perform budgetary control on all the corporate events and projects.
- Manage membership services and benefits and supervise the handling of incoming mails and enquiries relating to member services and corporate events.
- In charge of all Sports and Recreation Club (SRC) and the interest groups, and oversee all activities under the SRC and the Recreation and Sports Club for Hong Kong Professional Bodies.
- Lead and organize the logistics for the Council meetings, Annual General Meeting and Council election. Provide on-site support in the related meetings.

Qualifications and Required Attributes
