Go – Karting in Shenzhen

Following the over-whelming response to our first go-karting event in October 2011, the Institute is organising another go-kart weekend at *Xtreme Speedway* in Shenzhen. This will be a great experience for motorsports enthusiasts.

Xtreme Speedway is the only A-grade national race course in the Shenzhen area which is qualified for national racing events. Fully equipped with safety gear, electronic scoreboard, and spectator viewing area, it is one of the closest and best go-karting venues in the Hong Kong – Shenzhen area.

Whether you are a first-timer or an experienced go-kart racer, you are welcome to join this exciting sport event. There will be a race for those who wish to test their go-karting skills. Participants' safety is of paramount importance and all participants are required to strictly observe the rules and regulations and instructions from the event's leader, Michael Wong.
