中國書法課程 **楷書**

-劉才昌先生,香港中國書法家協會會長



課程內容

中國書法是漢字的書寫藝術，有如中華文化般源遠流長，也是一種很獨特的視覺藝術。

導師會在課程中教授會員中國書法的基本概念和增加會員對書法的造詣，共分以下三個階段，各十八節課堂：

- **楷書**：又稱正楷、楷體、正書或真書，是漢字書法中常見的一種手寫字體風格。其字形較為正方，不像隸書寫成扁形。在現代，楷書仍是漢字手寫體的參考標準。
- **行書**：是在楷書的基礎上發展起源的，介於楷書、草書之間的一種字體，是為了彌補楷書的書寫速度太慢和草書的難於辨認而產生的。
- **草書**：漢字的一種書體，特點是結構簡省、筆劃連綿。形成於漢代，是為了書寫簡便，在隸書基礎上演變出來的。有章草、今草、狂草之分。

導師履歷

劉才昌先生 一九三六年生，山東榮成人。現為香港中國書法家協會會長，香港中國書法研究所所長，香港美術家協會書法委員會主席，中國書畫函授大學教授。一九五五年考入北京大學，畢業後在大學從事教育工作二十餘年。書畫師從當代藝術大師劉海粟、徐北汀等，書法五體皆擅。其特點：用筆精到，富於韻律，結體嚴謹，流美多變。曾任中國書法家協會會刊〈中國書法〉編輯，在中國科學院、北京第二外國語學院、北京舞蹈學院、香港浸會學院等多個學院任教，並在北京電視台〈書法藝術〉專欄和香港電台〈神州縱橫〉節目中主講書法。其作品入選多屆全國書法篆刻展、二十世紀書法大展、中國當代書壇名家作品展及日本、韓國、新加坡等重大國際書法展。



作品入編〈當代中國書法作品集〉、〈當代書法藝術大成〉、〈中國當代著名書法家百人精品集〉、〈全國首屆著名作家、詩人、書法家、畫家聯展作品集〉、〈香港名家書法展集〉等專輯。名列〈中國古今書畫名人大辭典〉、〈中國當代書法家辭典〉、〈中國當代書畫家名人大辭典〉、〈中外名人辭典〉、〈香港名人辭典〉、〈中國當代名人錄〉、〈中國當代書畫家傳〉及〈中國美術年鑑〉等。在新華社香港分社工作期間，曾策劃、參與主辦內地和香港美術交流展一百多次。榮獲國內外書法大展金獎二十餘次。除書法創作外，在書法理論方面也多有建樹，其書法論文〈書法理論與創作管見〉榮獲文化部優秀獎。

劉才昌先生還對香港書法教育貢獻良多，桃李滿門。前新華社香港分社社長周南、副社長張浚生及前律政司司長羅德丞、全國政協委員陸達權、簡福飴等均為他的學生。一些學生現在國內外的高等院校任教。香港回歸祖國十週年之際，中國文藝報在隆重介紹香港各界名流中，大篇幅地對其進行了報導。劉才昌先生是中國當代最著名的十大書法家之一，國家級出版社為其編輯經典專輯行世，中國郵政還為他發行了十六張書畫作品專題郵票。
