## **Important Notice to All Candidates**

## **Bad Weather Notice**

If weather conditions are at all doubtful (such as the possible hoisting of Tropical Cyclone Warning Signal No. 8 or above; or the issue of the Red or Black Rainstorm Warning), all candidates who enrolled for the Examination in BAFS, organized by the Hong Kong Institute of Certified Public Accountants (the Institute) should pay attention to the radio or television broadcast, or view the website of the Hong Kong Examinations and Assessment Authority ("HKEAA") for examination schedules right up to the time they leave for the examination centre. It is important that all candidates should note the following points:

- a. where possible, the HKEAA's announcement of postponement of an examination session will be made approximately two hours before the commencement of the examination;
- b. the announcement of closure of schools due to a tropical cyclone or bad weather does not necessarily imply the postponement of an examination scheduled to be held on that day;
- c. HKICPA Examination in BAFS is a public examination administered by the HKEAA. As such, if HKEAA announces that all public examinations conducted by the HKEAA for the morning and/or afternoon sessions will be postponed, it means the HKICPA Examination in BAFS for that session will also be postponed; and
- d. once the examination session has started, it will continue for the full allotted time unless physical conditions in the examination room are considered to be dangerous by the Centre Supervisor.

Please note that if an examination has to be postponed, candidates may contact the Institute at 2287 7228 for enquiry/listening to a recorded announcement on the bad weather arrangement. The Institute will advise all candidates of the concerned HKICPA Examination in BAFS regarding the supplementary examination in due course.

## 香港會計師公會「企會財考試」 考生重要須知 惡劣天氣期間考試安排

如天氣不明朗(例如:可能改發八號或以上熱帶氣旋警告信號,或 懸掛紅色或黑色暴雨警告),所有已報考由香港會計師公會(公會)舉 辦的「企會財考試」之考生應於赴試場前留意電台、電視廣播或瀏 覽香港考試及評核局(考評局)網頁有關此考試安排的宣布。所有 考生須留意以下重要事項:

- a. 考評局會盡量安排在考試開始前大約兩小時內作出有關考試延期的 宣布;
- b. 即使在熱帶氣旋或惡劣天氣下,教育局宣布學校停課,原定該日舉 行的考試不一定會延期;
- c. 香港會計師公會「企會財考試」為公會委托考評局舉行的公開考試。 如考評局宣布所有原定在該日早上或/及下午舉行的公開考試將會 延期舉行,即表示原定在該期間舉行香港會計師公會「企會財考試」 亦會延期舉行;及
- d. 除非試場主考官認為該試場處於危險狀況,不適宜繼續進行考試, 否則當考試開始後,考試將會繼續進行,直至考試時間結束。

如考試因天氣惡劣須延期,考生亦可於當日致電香港會計師公會 2287 7228 查詢/收聽有關宣佈。其後,公會將會盡快通知所有考生 有關補考的安排。
