



Outstanding BAFS Student Awards 2020 **2020「企業、會計與財務概論」傑出學生獎**

Objective: The aim of the awards is to recognize candidates of the HKICPA/HKABE BAFS Mock Examination who have achieved an excellent result in Hong Kong Diploma of Secondary Education (HKDSE) Examination for the subject of "Business, Accounting and Financial Studies" (BAFS).

(A) Eligibility 申請資格

1. Applicants must have sat the HKICPA/ HKABE BAFS Mock Examination in 2019-20 Session.

2. Applicants must achieve Level 5** in HKDSE Examination for BAFS in 2020.
