
Pay in person at the Institute's member services counter at 27th Floor, Wu Chung House, 213 Queen's Road East, Wan Chai, Hong Kong.

- Payable to "Hong Kong Institute of Certified Public Accountants" or "HKICPA"

- Write your full name and membership number (if applicable) at the back of the crossed cheque
- Post the crossed cheque together with the payment slip
- Do not send post-dated cheque
