## About the programme and instructor

一首歌曲的完美表達，就是音樂和語言的結合，歌唱訓練並不單純是掌握聲音技巧，還必須把握語言規律，這樣才能在歌唱中表現聲音的魅力和語言魅力，達到聲音美與語言美的統一。

課程主要分為兩部分，基礎練習及歌曲演繹。

### 1. 基礎練習

**音階練習** - 利用不同咬字配合，讓學員發掘發聲位置；擴展個人音域，加強發聲及音準基本功。

**呼吸運用** - 讓學員懂得正確呼吸方法及有關肌肉配合，以改善歌唱時「唔夠氣」的情況。

**吐字技巧** - 每個字都是由一個音節組成的，而一個音節又可以把它分成字頭、字腹、字尾三部分，這三部分從語音結構來分。要想做到吐字清晰就要從這三方面入手加以訓練，不再成為歌唱發聲的障礙。

### 2. 歌曲演繹

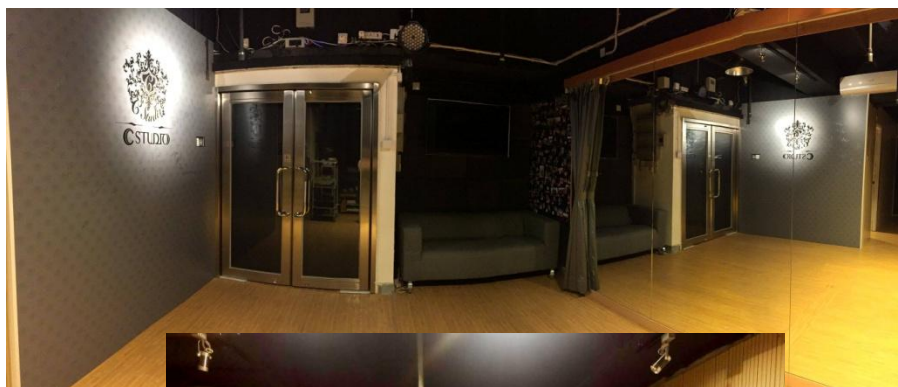
加強學員對歌詞、對旋律及節奏的感悟。在你深刻理解歌曲以後，更宜於表達情感。學員透過交流及分析，令學員加深了解自己不足之處繼而改善及進步，達致完美歌曲演繹。

#### 課程特色

- 無需任何歌唱經驗，適合初學人士。
- 完成課程後，可獲邀請於 **C Studio** 舞台參與演出 **Student Mini Concert**，享受實際舞台經驗。

**Carol Chan (陳嘉璐)**：踏足香港流行音樂界十五年，擁有豐富的歌唱表演及大小型演唱會嘉賓及和音經驗。早期參加香港流行曲公開賽獲得多項優異獎項，成績彪炳。亦曾受邀參與演出「謝安琪你們的幸福演唱會」，及為謝安琪『十七度』歌曲 **Demo** 歌手等等。近年來陳氏專注與培育新一代青年流行歌手，去年十月更受邀為二胡演奏家李軍先生之「李軍新二胡唱游流行夜第二季」擔任表演嘉賓，並帶領三位優秀學生組成“Catchie”和音團隊為該演唱會作伴唱。最近三年訓練之香港會計師公會代表參加 **Recreation & Sports Club for HK Professional Bodies Singing Contest** 獲得獎項，首先於 2015 年由 Adam Wong 及 Elaine Kwong 奪得〈合唱組－冠軍〉；2016 年學生們更榮獲四個獎項，分別由 Elaine Kwong 奪得〈獨唱組－冠軍〉及〈最佳台風獎〉，Jacqueline Hsui 及 Ruth Leung 奪得〈合唱組－季軍〉，並為香港會計師公會贏得〈我最喜愛演出獎〉獎項；2017 年 Natalie Tam 贏得〈獨唱組－亞軍〉，Adam Wong 及 Sandy Ngai 奪得〈合唱組－亞軍〉。
