The competition is divided into two categories: **Beginner** level of **Jive and Waltz**. A contestant can join more than one category with different partner.

- This is an amateur competition. Any paid instructor is not eligible to enter into the competition as a partner to our member. All contestants must neither have entered in any open dancing competition nor taken any dancing examination of the category that they enter. All contestants have to sign a declaration to confirm that they comply with these requirements. Please click here to download the declaration form.
- There is no fixed choreography or syllabus.
- This is a duo contest with **no** restriction on the sex of the contestants, ie. two fe/male are allowed to enter into the competition, provided one of them must be a member of HKICPA.
- Judges will look for posture; timing; line; hold; poise; musicality and expression; foot and leg action; lead and follow and floor craft.
- The duration of each dance is approximately 2 minutes.
- The entire competition including prize presentation will take place at the Dance Fun Night on 26
 October. First, second and third place will be awarded with trophies.
- Deadline for entry is 7 October 2013.
- No entry fee is required.
- The competition will be cancelled if there are less than 5 entries. Subject to the final number of entries, the competition may be divided into preliminary and final rounds taking place in the same evening.
