





Why accounting?

Accounting is the language of business. It is the indispensable element in the operation of every organization. Some of you may not dream of becoming an accountant but you may wish to become a decision-maker in businesses, such as a manager, an investor or a banker one day. HKICPA Examination in BAFS

The new senior secondary (NSS) curriculum aims to help students build a broad knowledge base and to foster the ability for them to learn throughout their lives. The HKICPA Examination in BAFS is tailor-made to meet the broadening NSS curriculum requirements.

The HKICPA Examination in BAFS is designed to provide a clear articulation pathway to the BAFS students who aspire to become CPAs. The HKICPA Examination in BAFS fully adopts both the format and syllabus of the HKDSE Examination for BAFS curriculum (both the compulsory part and the accounting module elective part). It aims to help students to prepare well for the HKDSE Examination, for the subject BAFS, develop and assess candidates' understanding and application of basic accounting and business knowledge, skills and values which required to meet different business needs. As such, the Examination in BAFS offered by HKICPA is the ideal mock examination for the HKDSE Examination in BAFS.

Take HKICPA Examination in BAFS to get level 5** in HKDSE Examination


The HKICPA Examination in BAFS equips BAFS students to prepare for HKDSE Examination. Commented by the HKDSE 5** students, HKICPA Examination in BAFS is highly recommended as an ideal mock examination for helping them to prepare well and achieve outstanding result in their examinations. In 2014, statistics show that over 70% of the "Top 50 secondary schools" (Note 1) have enrolled our examination and over 35% of candidates (Note 2) achieved level 5** in the 2014 HKDSE Examination in BAFS had taken the HKICPA Examination in BAFS.

報考香港會計師公會「企會財考試」為 中學文憑試取5**進發

香港會計師公會「企會財考試」能為「企會財」考生有效備戰香港中學文憑試。香港中學文憑試「企會財」科考獲5**的考生均強烈推薦我們的考試為「企會財」科的理想模擬考試,能幫助他們做好準備並取得優異成績。於2014年,數據顯示超過70%的"全港50強最具教育競爭力中學" 註1已報考

The above graph shows a result comparison of 2014 HKDSE Examination in BAFS between candidates and non-candidates of HKICPA Examination in BAFS. It demonstrates clearly our candidates achieved better result than others. In particular, the percentage of our candidates who achieved Level 5 or above in HKDSE Examination is 13.85% higher than those non-candidates. (Note 3)



Introduction to Hong Kong Institute of Certified Public Accountants

The Hong Kong Institute of Certified Public Accountants (The Institute) is the only body authorized by law to register and grant practising certificates to certified public accountants in Hong Kong. The Institute has more than 37,000 members and over 18,000 registered students. Members of the Institute are entitled to the description "certified public accountant" and to the designatory letters CPA.

The Institute was established on 1 January 1973. It operates under the Professional Accountants Ordinance and works in the public interest. The Institute has wide-ranging responsibilities, including assuring the quality of entry into the profession through its postgraduate CPA qualification programme and promulgating financial reporting, auditing and ethical standards in Hong Kong. The Institute has responsibility for regulating and promoting efficient accounting practices in Hong Kong to safeguard its leadership as an international financial centre.

香港會計師公會簡介

香港會計師公會(公會)是香港唯一獲法例授權負責專業會計師註冊兼頒授執業證書的組織,會員人數超過三萬七千,註冊學生人數超過一萬八千。公會會員可採用「會計師」稱銜(英文為certified public accountant,簡稱CPA)。

公會於一九七三年一月一日成立,公會根據《專業會計師條例》履行職責,以公眾利益為依歸。其廣泛職能包括開辦專業資格課程(Qualification Programme)以維持會計師的入職質素,以及頒佈香港的財務報告、審計及專業操守準則。此外,公會亦負責在香港監管和推動優良而有效的會計實務,以鞏固香港作為國際金融中心的領導地位。
