About the programme and instructor

Ukulele 夏威夷小結他的歷史:

夏威夷小結他(英語:Ukulele; 又翻作尤克裡裡、烏克麗麗), 簡稱 Uke, 是一種夏威夷的撥弦樂器, 歸屬在結他樂器一族, 通常有四條弦。Ukulele 分成高音(Soprano)、中音(Concert)、次中音(Tenor)與上低音(Baritone)四種尺寸, 其中以 Soprano 及 Concert 最為普遍及適合初學人仕。

課程內容

本課程為一級證書課程的初班 (參加者無須經驗)。整個一級證書課程共分為初、中、高3個單元(每個單元為4堂), 學員完成整個一級證書課程(即12堂)後將可獲由香港夏威夷小結他協會頒發 Ukulele 一級證書。

教授內容主要由基礎開始, 包括: 調音、抱琴姿勢、讀譜方法、按弦和基礎撥弦技巧等, 從 C Key 方面出發, 熟習 C Chord Family 的六大和弦, 從而令大家可以學會輕鬆自彈自唱一些簡單歌曲。
