

# Golf Day at Kau Sai Chau Public Golf Course (South and East courses)



The **Golf Interest Group (GIG)** has organised a golf day at Kau Sai Chau where members can choose to play in either the **South Course** (more player friendly for beginners or high-handicappers); or the **East Course** (more challenging for experienced players). This arrangement will be able to cater for different levels of players. Details as follows:

## Date: Monday, 19 December 2011

Time: 3 tee-off times at each golf course (i.e. total 6 flights) starting from about 8:24 am

## Venue: Jockey Club Kau Sai Chau Public Golf Course (KSC), Sai Kung

Handicap requirement: Men at **36.4** and Ladies at **40.4** or below Participants are required to indicate whether they have the KSC Golf Pass Certificate, or latest official handicap index (issued by HK Golf Association or other recognized golf associations/clubs). KSC requires that for South Course at least one player per flight with the required handicap level, and for East Course at least two players per flight with the required handicap level.

\* KSC requires an extra \$100/player for group booking below 16 players. The \$100 can be used on any purchase at the golf shop or restaurant at KSC within 12 months. However, if the total enrolment exceeds 16 players, KSC will NOT charge the extra \$100 and we will refund the cheque to members. Therefore **please** write out two cheques for the enrolment. One cheque for the green fee and ferry shuttle and the other for the extra \$100. Should the total number exceed 16 players, we will return your \$100 cheque by mail.

Flight leaders: Experienced golfers are invited to be flight leaders.

Lunch: <u>No</u> lunch arrangement will be made. Players can have lunch at KSC or in Sai Kung as they wish.

Transportation: Car pool, if required, will be provided by participants on a voluntary basis.

## Remarks

- The event will be cancelled if there are less than 8 players; or the handicap requirement for the group is not met.
- Complimentary use of electric golf cart on a sharing basis (not allowed on fairways or areas with turf).
- No caddy will be allowed.
- Ferry service departing from Sai Kung at 20-minute interval, on the clock, 20-min past and 40-min past. Players are recommended to take the 7:20 am or 7:40 am ferry (the latest).
- Assembly at the South/East Course Reception Counter on G/F, Administration Building. Exact time to be advised.
- Players are required to bring their own golf gear (clubs, gloves, balls, tees, etc), and wear proper golf shoes and attire.
- Complimentary use of locker/changing room facilities.
- KSC policy does NOT give refund for late cancellation and/or no-show after confirmation.
