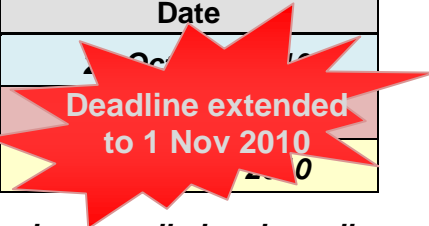

In 2008, they were officially placed 12th in the World Ranking Awards of the Professional Latin. Their phenomenal artistry brought them the title of the Hong Kong Closed Championship and the Asia Pacific Championship. They are now representing Hong Kong in all major championships.

### Ballroom teachers

**Mr. Kristjan Kuusk** or **Ms. Anri Kokkonen** or Alternate

Kristjan is Estonian and Anri is Finnish. They individually started dancing at the age of 9. In 2002 they started dancing together and represented Finland. Since then, they won many major championships in Europe and Asia and in 2008 was champion in French Open Ballroom Championship and in 2009 champion in major Asian competitions with the latest in Korea. In August 2010, they won the Finnish Professional Ballroom Championship.

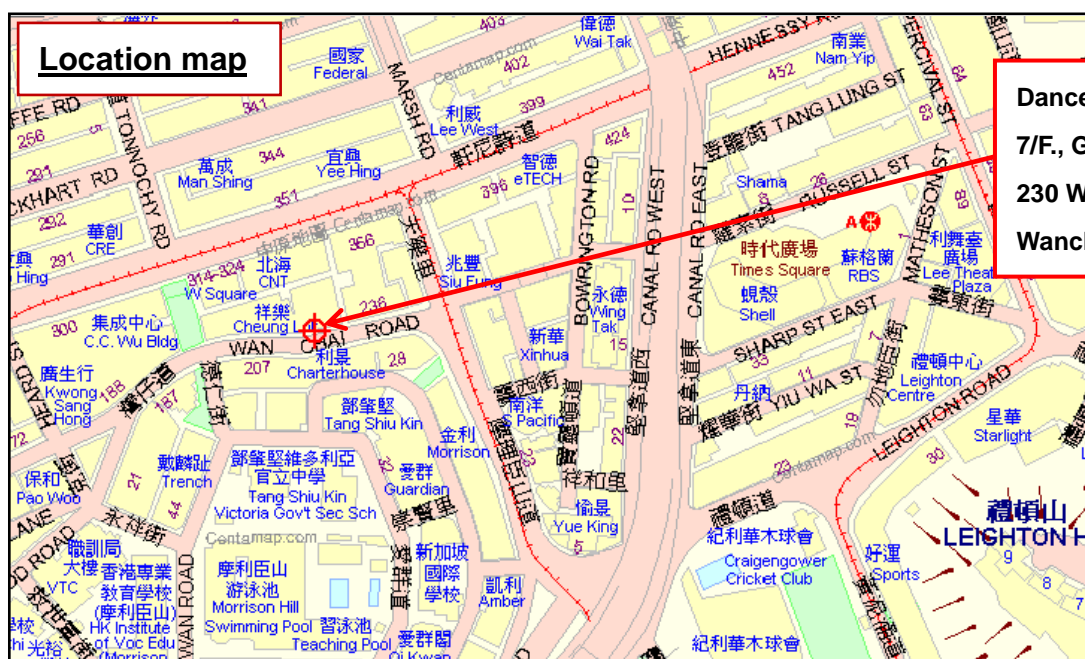
