





## CHARTERED ACCOUNTANTS' HALL – THE HISTORIC HEADQUARTERS OF THE ICAEW

Situated in Moorgate Place, in the heart of the City of London, Chartered Accountants' Hall now spans three centuries. Opened in 1893 to serve an Institute of 1,700 members, it has been extended, adapted and modernised as membership has grown beyond 130,000. But the Hall's principal function, to serve as a meeting place and a library for its members, remains unchanged.

Built in Italian Renaissance style to the design of the eminent Victorian architect, Sir John Belcher RA, the Grade II listed building remains one of the City's hidden masterpieces in a time of modern steel and glass structures.
