## About the programme and instructor

1. 基本認識 – 結他結構講解，調音器應用及認識指板。
2. 和弦練習 – 結他“四大和弦”學習與運用。
3. 歌曲實戰 – 以經典歌曲作教材，令學生輕易學會一首歌。
4. 自彈自唱秘訣 – 旋律及拍子配合手口之協調。
5. 舞台技巧 – 器材運用及準備功夫，採排期間與技術人員 (Soundman) 溝通之術語。

### 課程特色

- 無需任何樂器演奏經驗，但對唱歌有基本認識之人士。
- 學生可選擇自行購買以下所需器材或於上課期間借用課室內之結他器材作學習用途。
- 完成此課程後，更可延續報讀 Music Stage 結他合奏班(Level 1-8)之課程。
