The oral presentation of the accounting and business management case competition 2016-2017 was successfully held on 29 April 2017 at HKICPA auditorium. A total of 526 teams with 1,080 students from around 150 schools joined in both Level 1 and Level 2 competitions this year.

This annual event allows students to apply their textbook knowledge in the areas of accounting and business to the real commercial world. It also enhances students' soft skills such as analytical thinking, time management, presentation skills, creativity and team building.

Bauhaus International (Holdings) Limited (Bauhaus) was the company selected for this year's case study. Participating teams, which comprise three to five members, were required to submit a written business proposal analyzing Bauhaus' business performance and to give a recommendation on strategies to sustain the company's growth. Based on the business proposals, the reviewers shortlisted, through a blind review, the best six teams to enter the final round of the competition, the oral presentation, and compete for the championship.
