Snooker is a billiards sport that requires skills to use a cue ball to pot the red balls and colored balls into the pockets. The popularity has been increasing among members since the first snooker activity held in 2011. To meet members' demand, the Snooker Interest Group has organised new training courses for different levels of players as follows:
