Maximum players North Course - 8 players (with lowest handicaps); South Course - 14 players

Format Individual Stableford off New New Peoria Handicap (NNP)

The perpetual trophy will be awarded to the Champion team and medals to team members of the champion, 1st and 2nd runner-up. **Prizes**

Trophies will be awarded to the Best Gross Score in North Course and South

Course for each team.

Trophies will be awarded to the Highest Stableford Point in North and South

Course for each team.

Trophies will be awarded to the winner who has won the Nearest to Pin and

Longest Drive in North and South Course. Between these awards, only one award

can be won by any one player.

There will be a separate prize for men and women for the Longest Drive in South

Course.
