Session	Date	Course outline
Session 1	17 January 2014, Friday	Introduction of the bidding system in simplified version for adoption e.g. All Natural, SAYC (Standard American Yellow Card), and Precision Club.
Session 2	24 January 2014, Friday	Review of the technique on declarer play.
Session 3	6 February 2014, Thursday	Suggested methods to be adopted in defense.
Session 4	7 February 2014, Friday	Scoring methods in Rubber and Duplicate Bridge.

Each session will spend 30 to 45 minutes for discussion. Practice session is included.

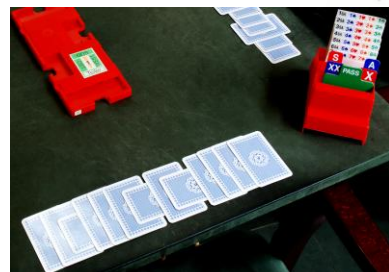
