


CPA Table Tennis Competition 2015

Eligible player: HKICPA members only

Competition Information:

- Events include Men's Singles, Women's Singles, Men's Doubles, and Mixed Doubles
- An event will only proceed if there are at least 4 singles or 4 pairs in the case of doubles
- The maximum number for each event is 30 singles or 12 pairs, subject to change based on the final enrolments
- Each member can join up to three events
- The competition will be cancelled if less than 3 events can be held.

Match format:

- Contestants will be divided into groups and matches will be conducted in round robin in the preliminary round. Thereafter, the playoffs will be by single knock out. The number of matches varies according to the number of contestants registered.
- Event(s) with less than five contestants will be played on single round robin basis.
- There will be five games of 11 points in each match; and the contestant who wins three games first will win the match.
- The match format may vary subject to the final number of contestants. Detailed match format will be announced in due course.
- All matches will be conducted and supervised by professional umpires whose decisions are deemed final. No appeal will be entertained.

Awards: Champion and 1st, 2nd and 3rd Runner-up for each event

Admission Fee: \$80 for ONE event; \$100 for more than one event

- 1. Enrolment for the competition is accepted on a first-come-first-served basis.
- 2. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- 3. The closing date for enrolment is <u>27 September 2015</u>. However, the Institute has the discretion to accept late applications as it sees fit.
- 4. Application by fax will ONLY be accepted when payment is made by credit card or cheque. Cash is strictly NOT accepted.
- 5. Successful enrollees will receive confirmation by email or by telephone, whereas unsuccessful applicants will receive full refund by mail

- 7. Unless the activity is cancelled due to unforeseen circumstances, bad weather or low enrolment, no refund for withdrawal will be entertained after your enrolment has been processed.
- 8. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 is hoisted 2 hours prior to the commencement of the activity. Your enrolment fee will be refunded in full in the event of cancellation due to bad weather, or subject to separate arrangement with the venue provider.
- 9. The Institute reserves the right to change the venue and date of the activity due to unforeseen circumstances.
