



Golf Day at Kau Sai Chau Public Golf Course (East Course)

The **Golf Interest Group (GIG)** has organised a Golf Day (18 holes) for its members to experience the East Course of Kau Sai Chau Public Golf Course – a challenging course with excellent sceneries. We are looking for a maximum of 5 flight leaders, subject to the actual number of flights.

Date: **24 January 2011, Monday**

Time: 5 tee-off times starting from **12:00 pm**

Venue: **East Course, Jockey Club Kau Sai Chau Public Golf Course (KSC), Sai Kung**

Handicap requirement: Men at 36.4 and Ladies at 40.4 or below
 Participants are required to indicate whether they have the KSC Golf Pass Certificate, or latest official handicap index (issued by HK Golf Association or other recognized golf associations/clubs). KSC requires that at least 75% of players have the required handicap level, i.e. only one player in each flight can be a non-handicapper.

* KSC requires an extra \$100/player for group booking below 16 players. The \$100 can be used on any purchase at the golf shop or restaurant at KSC within 3 months. However, if the total enrolment exceeds 16 players, KSC will NOT charge the extra \$100 and we will refund the same to members. Therefore **please write out two cheques for the enrolment. One cheque for the green fee and ferry shuttle and the other for the extra \$100.** Should the total number exceed 16 players, we will return your \$100 cheque by mail.

Flight leaders: Experienced golfers are invited to be flight leaders.

Dinner (optional): Seafood dinner will be arranged at participants' own expenses on a sharing basis (about \$400 per person) at Loaf On Restaurant (Michelin 1 Star in 2009) in Sai Kung. Details will be given by Kevin Yuen, the GIG co-convenor nearer the event date.

Transportation: Car pool, if required, will be provided by participants on a voluntary basis.

Remarks

- The event will be cancelled if there are less than 8 players; or the handicap requirement for the group is not met.
- With complimentary use of electric golf cart on a sharing basis (not allowed on fairways or areas with turf).
- No caddy will be allowed.
- Ferry service departing from Sai Kung at 20-minute interval, on the clock, 20 min past, 40 min past.
- Assembly at the South Course Reception Counter on G/F, Administration Building. Exact time to be advised.
- Players are required to bring their own golf gear (clubs, gloves, balls, tees, etc), and wear proper golf shoes and attire.
- Complimentary use of locker/changing room facilities.
- KSC policy does NOT give refund for late cancellation and/or no-show after confirmation.
