About the programme

For the first time in its history, China has a unified and comprehensive bankruptcy system covering all types of enterprises, including foreign investment vehicles. The new bankruptcy law is a major milestone for China, a country that has spent the past decade deliberating on an enforceable bankruptcy law applicable all enterprises, including state-owned enterprises.

However, implementation problems and challenges still lie ahead due to the lack of transparency, the small number of local practitioners qualified to act as administrators and the inexperience of the judiciary in handling bankruptcy cases of large enterprises. Nevertheless, while Chinese insolvency practices remain in their infancy, the new bankruptcy law marks a significant achievement for China as it moves further towards a market economy.
