Carol Chan (陳嘉璐)：踏足香港流行音樂界十五年，擁有豐富的歌唱表演及大小型演唱會嘉賓及和音經驗。早期參加香港流行曲公開賽獲得多項優異獎項，成績彪炳。亦曾受邀參與演出「謝安琪你們的幸福演唱會」，及為謝安琪『十七度』歌曲 **Demo** 歌手等等。近年來陳氏專注與培育新一代青年流行歌手，去年十月更受邀參與演出二胡演奏家李軍先生之「李軍新二胡唱游流行夜第二季」擔任表演嘉賓，並帶領三位優秀學生組成“Catchie”和音團隊為該演唱會作伴唱。最近兩年訓練之香港會計師公會代表參加 **Recreation & Sports Club for HK Professional Bodies Singing Contest** 獲得獎項，首先於 2015 年由 Adam Wong & Elaine Kwong 奪得〈合唱組－冠軍〉；2016 年更榮獲四個獎項，分別由 Elaine Kwong 奪得〈獨唱組－冠軍〉及〈最佳台風〉，Jacqueline Hsui 及 Ruth Leung 奪得〈合唱組－季軍〉，會計師公會奪得〈我最喜愛演出獎〉獎項。
