### Annual award and graduation ceremony 2010



On 24 September 2010, the Institute conferred certificates on 1,888 students who passed the final examination of the QP at the annual award and graduation ceremony. Officiated by the guest-of-honour, Ms. Au King-chi, Permanent Secretary for Financial Services and the Treasury, 11 top QP candidates received awards of merit, 21 outstanding students received QP scholarships and 39 top accounting students from 16 universities and educational institutions in Hong Kong and Mainland received the Hong Kong Institute of CPAs scholarships.
